his heirs &c or a Guardian or Guardians all the estate Real and personal of the said Orphan that  
he shall take into his hands & possession peaceably and quietly whenever the same should be legally required.

Whereupon Elizabeth Bush an Orphan above the age of fourteen years by her intent and  
Joseph Collins in her Major Person and says that he may be permitted to choose a Captain for his Master  
her Guardian of Somerset County as her Guardian which is by the Court hereunto her Granted Therupon  
the said Elizabeth Bush present herein Court as aforesaid choice of the aforesaid Joseph Collins as her Guardian  
Accordingly Whereupon the said Joseph Collins present herein Court in his Major person is ordered by  
the same Court to take into his care and Despatch the aforesaid Elizabeth Bush Orphan aforesaid and all her estate  
Real and personal and further it is Ordered that a Captain Peter Thelland delivering up unto the aforesaid  
Guardian all the estate of the aforesaid Orphan whatsoever soever that he hath in his hands and possession and  
that of Right doth belong unto the aforesaid Orphan and that the aforesaid Guardian give good security to comply with  
the laws in Relation to such Guardianship as of and to deliver up unto the aforesaid Orphan his heirs & &c  
all her estate Real and personal that he shall take into his hands & possession peaceably and quietly  
whenever the same should be legally required. Whereupon the said Joseph Collins together with John  
Hollum and Wilson Rider of Somerset County Planters his security all present herein Court in their proper  
Persons acknowledged themselves bound unto the said Elizabeth Bush Two hundred pounds Current money  
of Maryland of their Body Goods or Cattle Lands and tenements jointly and severally to the use of the said  
Elizabeth Bush her heirs and assigns to be made and levied if it happen that the said Joseph Collins —  
Guardian as of her heirs &c do not comply with the laws in Relation to such Guardianship  
as of and do not deliver up unto the aforesaid Elizabeth Bush her heirs &c or a Guardian or Guardians  
all the estate Real and personal of the said Elizabeth Bush that he shall take into his hands and  
Despatch peaceably and quietly whenever the same should be legally required.

Joseph Dashill <sup>Appointed Guardian</sup> Joseph Dashill of Somerset County Gentleman being present herein Court in his proper  
Person and of his own free Consent is appointed by the same Court as Guardian to a Captain  
William Hobbs an Orphan under the age of fourteen years until he the said William  
Should arrive at full age by Law for the Riving of his Guardian &c And forasmuch as no person would accept  
of the Guardianship of the aforesaid Orphan and his estate in the common way of Guardianship the Court hereunto  
at the aforesaid Orphan and his estate to the aforesaid Joseph Dashill as his Guardian Accordingly in manner following  
tis Agreed by and between the aforesaid Guardian and the Justices aforesaid judicially sitting on behalf  
of the aforesaid Orphan that he the said Guardian is to be in no wise accountable for the loss of the Haves of the  
aforesaid Orphan that he shall take into his hands & possession but shall take care of them and preserve them  
and their increase in the best manner he can for the use of the said Orphan neither shall he detain in his hands  
and possession any of the Principal that is to say the increase of the said Haves of the aforesaid Orphan to deliver  
them up later peaceably and quietly whenever the same should be legally required.

Whereupon the said Joseph Dashill Guardian aforesaid is Ordered to take the aforesaid Orphan and his estate  
Real and personal into his hands & possession and give good security to comply with the laws in Relation  
to such Guardianship and Agreement as of. Whereupon the said Joseph Dashill together with Robert Grahame  
and John Graham of Somerset County his security all present herein Court in their proper Persons acknowledged  
the same to be lawfully required.
