Thomas Wright being very Infirm and not able to Labour is set free by the Court here until it shall please the Court to Restore him to his health and able to Labour &c.

Samuel Noddall To the Worshipfull Justices of Somerset County now in Court Judicially sitting The Petition of Samuel Noddall humbly sheweth that whereas your Petitioner is in possession of a certain Land lying in this County called Friendship and of some other called Aquintina the Boundaries whereof are uncertain and Precarious and the Evidence to prove the same aged and infirm your Petitioner therefore prays that your Worshipps would appoint Commissioners to meet on the said Land in Order to examine Evidence relating to the Boundaries thereof of any others that be contiguous or depending and by your Petitioner as in Duty bound will pray &c.

Whereupon came hereinto Court the said Petitioner in his proper person and thereupon the Petition of being Read and heard and fully understood it is Considered by the Court here that a Commission be made to the said Samuel Noddall by the petition of is provided and that Edward Waters Justice of the Peace Isaac Mitchell and William Manning of Somerset County be the Commissioners and hence the same Commission according to Act of Assembly in such case provided &c.
