In his proper person had a hearing of the Court of said County that she cannot deny but that she is guilty of the Breaches in the Countment above upon her Imposition named and sworn as by the Countment of above against her supposed and made Oath that a negro named is of father of the child she stands informed against and is willing to pay her fine for the same

Whereupon all and singular Breaches being seen and by the Court here fully understood it is considered by the Court here that the said Lady Wright for the Breaches and offence of the said Breaches and offence of thirty shillings current money of Maryland which she paid in Court to the use of the County as aforesaid
Whereupon the said Lady Wright is adjudged to give security for the Payment of the same Officers due by means of the Prosecutors of the County
Whereupon a certain Joseph Allen Esquire herein Court in his proper person undertook for the said Lady Wright to pay of several Officers their fees due by means of the Prosecutors of the County

MS Jane Sambden
Command was given to the Sheriff of Somerset County that he should take the said Joshua Atkinson late of Somerset County in holder if he should be found in his County Court of Somerset to be held at Quince Ann Town the third Tuesday of March term here one thousand seven hundred and sixty to answer unto Jane Sambden of a plea of Trespass upon the Case of the fourth

And the same day is given to the said Jane Sambden here of the said
At which day here came the aforesaid Jane Sambden by William Hayward her Attorney and the Sheriff to wit John Dennis Gentleman now here returned that he had taken the said Joshua Atkinson whose body there at this day he had ready to answer the said Jane Sambden of the plea as to him it was commanded
Whereupon the said Joshua Atkinson at the prayer of the said Jane Sambden is adjudged to give special Bail to the said Jane Sambden in his proper person undertook for the said Joshua Atkinson that if it should happen that judgment in the plea aforesaid should be rendered for the said Jane Sambden against the said Joshua Atkinson or that he the said Joshua Atkinson should be therein convicted that then he the said Joshua Atkinson should pay and satisfy unto the said Jane Sambden of judgment of the Court thereupon or render his body in Execution of such judgment to the Prison of the Sheriff of the County aforesaid in satisfaction thereof or that he the said Joshua Atkinson will do the same for him

Whereupon the said Joshua Atkinson put in his place Samuel Wilson Gentleman Attorney at Law against the said Jane Sambden in the said plea

And thereupon at the prayer of the said Joshua Atkinson a day is to them here now given until next Court to be held at Quince Ann Town the third Tuesday of June then next following in the State that now saving to the said Joshua Atkinson
At which day here came the said Joshua Atkinson by the said Attorney aforesaid and thereupon the said Jane Sambden complained of the said Joshua Atkinson in the said plea of the said form following
