 the Justices of Somerset County Court and their Successors from all Troubles, Suits, Damages,
 Charges that might be lawfully made by means of the said Child, Maintenance of the said Child.
 Thereupon the said Aaron Starling together with Sillitron Dennis of Somerset County
 Gentleman his Security both present herein Court in their proper persons acknowledged
 themselves indebted unto his Lordship of Right Honorable Lord Bishop in Trusty
 Bonds Current money of Maryland of their Trade Goods Chattels Lands or
 Tenements jointly & severally to be made, Sworn to by use of the Inhabitants of
 Somerset County for y^e time being, if it happen that the said Aaron Starling his heirs
 Exors or Admors any or either of them do not from time to time and at all times hereafter
 Acquitt Discharge, Save harmless as well y^e Justices of Somerset County Court for y^e time
 being, as also the Inhabitants of said County, of and from all such Charges, Troubles
 Whatsoever for or by reason of the said Child Maintenance nourishing & bringing up of
 the said Child and of y^e from all other Suits, Troubles and Demands whatsoever touching
 or concerning of the same.

His Lordship of Somerset to wit at this Remembred that William Hayward Gent.
 Also Grieffen ^{Att^r} of the Right Honorable the Lord Bishop that now is who for y^e same
 Lord Bishop held for Somerset County to wit at Bineus Am. Town
 in the same County the eighteenth day of November in y^e year of our Lord
 one thousand seven hundred and Sixty before said William Hayward Esq^r and others his
 Associates the said Lord Bishop his Justices of y^e same County, Court and for y^e
 same Lord Bishop doth give y^e same Justices to understand, he informed
 that Alice Grieffen Native of Coventry, Parish in the said County of Somerset the
 sixteenth day of November in the year of our Lord one thousand seven hundred and fifty
 nine at the Parish of y^e County aforesaid did commit fornication with a certain
 Person unknown and did permit y^e same unknown Person to have carnal knowledge
 of her body and a Bastard Child on y^e body of her y^e said Alice then and then to beget
 to the High Dishonour of Almighty God to y^e bad example of all others in such case
 offending contrary to the Law of the said Lord Bishop that now is his good Rule and
 Government and Against the Form of the Act of Assembly in such case made
 and provided and for the whereupon y^e same Attorney of y^e same Lord Bishop
 for y^e said Lord Bishop gave advice of y^e Court herein y^e Curmises and that due
 Course of Law may in this part be on adv against y^e said Alice to answer of and
 upon y^e Curmises and Objections.

Thereupon it is Comanded y^e Sheriff of Somerset County that he should take y^e
 said Alice Grieffen to answer.

And now to wit at a Court of his Lordship held at Bineus Am. Town y^e third Tues.
 day of November Anno Domini one thousand seven hundred and Sixty before y^e
 Justices thereof namely of Alice Grieffen in her proper person according to a certain
 by her in that part before acknowledged and had a hearing of y^e Information
 of y^e said Alice that she cannot deny but that she is guilty of y^e Curmises in y^e
 Information aforesaid upon her Imposed in manner form as by y^e
 Information aforesaid above of y^e her supposed, is willing to pay her fine for y^e same.
