of Shirey in y<sup>e</sup> County aforesaid spinster on y<sup>e</sup> first day of November anno  
Domini MDCCLX at y<sup>e</sup> Parish aforesaid in y<sup>e</sup> County aforesaid with fawnd arms in  
and upon a certain Tribeca Martin in y<sup>e</sup> heaw of god to y<sup>e</sup> said lord  
Proffit then being am y<sup>e</sup> vault de maker her of y<sup>e</sup> said Tribeca then  
then did beat wounde wiche that sothat of her diffet was murely gash-  
and other harme to her of y<sup>e</sup> said Tribeca then there did do great damage  
of her of y<sup>e</sup> said Tribeca against y<sup>e</sup> heaw of his Lordship of Right Honble  
of y<sup>e</sup> said Proffit that now is his good ruler government &c

Whereupon it was commanded by Sheriff of Somerset County that immediately he  
should take of y<sup>e</sup> said Mary Martin if he can to answer

And now to wit at Court of his Lordship held at Parishes Towne this instant  
November before y<sup>e</sup> Justies then of Camry aforesaid Mary Martin inter priser  
person according to a certaine recognizance by her & her body in that case  
first acknowledged had a hearing of y<sup>e</sup> Indictment &c. saith that she will  
not be hindred with his said Lordships but say y<sup>e</sup> having past labours and  
expenses about y<sup>e</sup> summons Submitt her selfe at y<sup>e</sup> fire with his said  
Lordship by occasion of y<sup>e</sup> summons & putt her selfe upon prouer of y<sup>e</sup>  
Court

Whereupon alz singular y<sup>e</sup> summons being run by y<sup>e</sup> Court  
unfull y<sup>e</sup> understood it is considered by y<sup>e</sup> Court true that y<sup>e</sup> said Mary  
Martin for y<sup>e</sup> summons stans at y<sup>e</sup> Indictment aforesaid above shewd  
taken &c.

Whiche said Mary Martin present here in Court aforesaid is fined for y<sup>e</sup> summons  
and expenses of sum of Twillie shillings current money of Maryland  
wherewithal her to pay to y<sup>e</sup> Sheriff of y<sup>e</sup> County aforesaid for y<sup>e</sup> use of his  
said Lordship &c.

Whereupon a certain John Godard Present here in Court in his proper person  
undertook for y<sup>e</sup> said Mary Martin to pay y<sup>e</sup> several officers their fees due by  
means of y<sup>e</sup> execution of y<sup>e</sup> same

His Lordship of Somerset towit therit remembred that William Hayward gen<sup>r</sup>  
Esq<sup>r</sup> Barr<sup>r</sup> Attorney of y<sup>e</sup> Right Honble of y<sup>e</sup> said Proffit that now is his good  
who for y<sup>e</sup> same said Proffit in this Case prosecute doth come herinto  
the County Court of y<sup>e</sup> same said Proffit held for Somerset County towit at  
Parishes Town in the same County y<sup>e</sup> eighteenth day of Nov<sup>r</sup> in y<sup>e</sup> year of our  
Lord one thousand seven hundred and sixtie, to y<sup>e</sup> few days Mandy last and  
others his associates of y<sup>e</sup> said Lord Proffit his Justices of y<sup>e</sup> same County
