The Deposition of James Knight of Somerset County aged fifty eight Years -
Sworn on the holy Evangelist of Almighty God saith that he Sunday times saw a Black Gum
tree about being seen on the holy Evangelist of Almighty God saith that he Sunday times saw a Black Gum
tree in a Boundary Standing in a thicket of Wood to the Westward and about an hundred Yards distant
from Dividing Creek which tree this Dependant was informed by Comfort Banton and John Harris was
a Boundary tree of a tract of Land called Bear Point which Land the said Harris and Banton were then in
Possession of and this Dependant further saith that the said Gum tree was commonly deemed by all the Neighbors
Adjacent to the Boundary of the said Land called Bear Point which tree stood in the spot where a Course
Bears South sixty eight degrees East thirty nine Perches distant from the South East Corner of Isaac Carters
Dwelling house and also a Course Bearing South Eighteen degrees East Twenty four perches distant from
a Hickory Noked on these sides and further saith not -

The Deposition of Hannah Pizzen of Somerset County aged fifty One Years - these abouts being
Sworn on the holy Evangelist of Almighty God saith that when she was a Girl she Sunday times saw a Black
Gum which appeared to be a Boundary Standing in a thicket of Wood a little distance to the Northward of
a small Gully spring from Dividing Creek which tree this Dependant saith she was often showed by her Father
and Mother and told by them that the same was a Boundary of a tract of Land called Bear Point
and a Gum tree of a tract of Land called Carters houle which which tree stood in the spot where a Course bears
South sixty eight degrees East thirty Nine Perches distant from the South East Corner of Isaac Carters dwelling
house and also where a Course Bears South Eighteen degrees East Twenty four perches distant from a Hickory Noked
on these sides and further saith not -

The Deposition of Joseph Pizzen of Somerset County aged fifty One Years - these abouts being sworn
on the holy Evangelist of Almighty God saith that about Twenty Years past he was informed by Isaac Carter
and Comfort Banton that the Boundary of the said Isaac Carters Land stood in Dividing Creek and further saith not -

The Deposition of Gideon Silman of Somerset County aged Twenty eight Years - these abouts
being sworn on the holy Evangelist of Almighty God saith that about fifty Years past he was employed as
Chain Carrier when William Whittington who was then the Surveyor was called upon by Stephen Carter to divide
some Lands between him and his Mother and Beginning at a Deplar being the first Boundary of a tract of Land
called Carters houle and in running the first Course of said tract it carried them into Dividing Creek at which
Time Comfort Banton the Mother to the said Carter being present found fault with the Surveyor and had leave
Money for the said the Gum Boundary stood by the Creek and further saith not taken this 30th Day of May Anne
D^{ns} 1761 -
