And the afd Sarah Durothy in her proper person Comes and Sweth that
 she cannot gainsay the Judgment afd so as afd against her brought nor but
 that she is guilty of the premises above upon her imposed as by the afd Judgment
 it is alleged & Thereupon Submits to the Court Therefore it is Considered by
 the Justices here this 20th Day of June Anno Dom 1727 that the s^d. Sarah
 Durothy pay the Sum of Six hundred Pounds of Tobacco as a fine for her
 afd offence of Committing fornication in form afd Confoit ~~as~~ Considered
 that y^e. s^d. Sarah pay the Sum of two hundred and twenty five pounds of
 Tobacco Costs amounting on the premises afd to the officers of this Court —

Ordered by the Court here that the Sher of Front County keep y^e. said Sarah
 Durothy in safe Custody until she shall satisfy y^e. fine and fees in the
 Judgment afd Specified in y^e. whole amounting to Eight hundred and
 twenty six pounds of Tobacco —
