**T**HE house met. Present the same members as on yesterday. The proceedings of yesterday were read. Mr. Riggold, from the committee, delivers to the speaker a bill, entitled, An act to authorise the justices of the levy court of Washington county to assess a sum of money on the taxable property of said county for the purposes therein mentioned; which was read the first time and ordered to lie on the table.

Petitions from Basil Pool, of Frederick county, and Richard G. Hardesty, of Prince-George's county, praying acts of insolvency, were preferred, read, and referred to the committee appointed on petitions of a similar nature.

The bill, entitled, An act to ratify and confirm the proceedings of the committee of the Buckingham congregation in Worcester county, and for other purposes, was read the second time and passed; which, together with the bill, entitled, An act for the more effectual preservation of wild deer in Somerset county, the resolution in favour of James Boarman, of Charles county, and the resolution relative to the proprietary debt books, were sent to the senate by the clerk.

A report of the trustees of the Easton academy, stating, that it would tend to the advantage of that institution if the annuity was applied to erect a suitable building, and praying that they may be authorised to do the same, was preferred, read, and referred to Mr. Dickinson, Mr. Lloyd and Mr. Spencer, to consider and report thereon.

The clerk of the senate delivers a bill, entitled, An act relative to sheriffs and constables, endorsed; "By the senate, November 23, 1805: Read the first time and ordered to lie on the table.
