A petition from sundry inhabitants of the city of Baltimore, praying an extension of Pratt-street, was preferred, read, and referred to the committee appointed on a petition of a similar nature.

ORDERED, That the bill to streighten and amend the old road leading from Randall's-town to George Beams's, commonly called The Liberty-town Road, be recommitted for amendment.

THE committee to whom was referred the petition of Luther Martin, of the city of Baltimore, having duly considered the same, are of opinion that the prayer of the petitioner is reasonable and ought to be granted, and therefore submit the following resolution :

RESOLVED, That the said Luther Martin have permission to pay to the state of Maryland the balance due to the said state on account of confiscated property by him purchased, and for which the said state hath judgments against him, in four annual and equal instalments, with interest thereon, the first instalment to be paid on the first day of December, 1806, and that no execution shall, in the intermediate time, be issued upon the said judgments, except on failure of paying the said instalments, or either of them, at the times appointed by this resolution.
