Whereas it is of importance to every republican government to encourage, by every means in its power, the enterprising and patriotic exertions of its citizens in defence of their country: And whereas George Washington Munn, a citizen of this state, in conjunction with O'Bannon, was the first to establish the American standard, under the command of general Eaton, on the walls of Derne, thereby signalizing himself for his bravery, and contributing to the delivery of many of our fellow-citizens from bondage; therefore Resolved That the governor and council be and they are hereby authorised and required, to procure a handsome sword, with an appropriate engraving and motto, emblematic of the action of Derne, and cause the same to be delivered to the said George W. Mann, in testimony of the high sense of approbation the legislature of this state entertain of his gallant conduct.

The report of the committee of conference respecting the situation of the government property appropriated

to the use of the governor, was read the second time and the resolutions therein contained assented to.

The following order was read.

ORDERED, That the committee of claims allow on the journal of accounts the sum of twenty-five dollars to each of the committee clerks, as a further compensation in addition to their per diem, and place the same on the journal of accounts.

And the question was put, That the house assent to the same? Determined in the negative.

On motion, Leave given to bring in a bill, entitled, A supplement to an act, entitled, An act respecting the acknowledgment of deeds. ORDERED, That Mr. Smoot, Mr. Shaaff and Mr. Ward, be a committee to prepare and bring in the same.

The bill annulling the marriage of Sally Lutig, of the city of Baltimore, was read the second time, and the

guestion put, Shall the said bill pass? Determined in the negative.

The house adjourns until to-morrow morning 9 o'clock.
