

The following resolution was read the first and second time by especial order, passed, and sent to the senate by the clerk.

RESOLVED, That so much of the resolution which passed during the present session of assembly, appropriating money for repairing and furnishing the government-house, as relates to furnishing the same, be and the same is hereby rescinded.

The engrossed bills from No. 62 to 89, inclusive, were read and assented to, and sent to the senate by the clerk.

On motion, the question was put, That the house dispense with the 16th rule thereof? The house being equally divided, it was declared in the affirmative by the speaker.

The house proceeded to the second reading of the resolution relative to the chief judge of the sixth judicial district, and the question put, That the words "fifth and" be inserted between the words "the" and "sixth?" Determined in the negative.

The question was then put, That the words "third and" be inserted in the same place? Determined in the negative.

The question was then put, That the said resolution be referred to the next general assembly? The yeas and nays being required, appeared as follow:
