The speaker laid before the house a letter from Robert Wright, junior, declaring he meant not to infringe the privileges or rules of decorum of the house by assaulting the officer thereof; which was read and referred to the committee of grievances and courts of justice.

The clerk of the senate delivers the following message:

By the SENATE, January 5, 1807.

Gentlemen of the House of Delegates,

WE have also acted upon all the business before us, and propose to have the laws that have passed immediately signed and sealed by the governor. We have agreed to adjourn to the first Monday of November next.

The following resolution was read the first and second time by especial order.

Whereas various means have been proposed by this legislature for the disposal of the surplus money in the treasury without effect, and as it is necessary to dispose of it in some way whereby it may be productive of advancing the interest of the state; therefore Resolved, That the treasurer of the western shore be and he is hereby authorised and directed, to purchase stock in the funds of the United Strtes to an amount not exceeding eighty thousand dollars, provided the same can be done on advantageous terms, of which the treasurer shall judge.

And the question put, That the house assent to the same? Determined in the negative.

Mr. Partridge and Mr. M'Elderry, from the senate, inform the speaker that the governor is attending in the

senate to sign and seal the engrossed bills, and request the attendance of this house for that purpose.

12. A Further additional supplement to an act, entitled, An act to regulate the inspection of tobacco.

- 13. An ACT to appoint and authorife commissioners to review and lay out the road therein mentioned in Harford county.—
 14. An ACT to confirm and make valid certain proceedings of the orphans courts in different counties of this state, or the justices thereof.
