A petition from sundry inhabitants of Frederick-town and county, praying for a road from Frederick-town to Washington county line through Middle creek valley, and petitions from said county counter thereto, were preferred, read, and referred to Mr. Kuhn, Mr. Hawkins, Mr. Bowles, Mr. Schnebly and Mr. Briscoe, to consider and report thereon.

On motion, Leave given to bring in a bill, entitled, A supplement to an act, entitled, An additional supplement to an act, entitled, An act relating to negroes, and to repeal the acts of assembly therein mentioned. ORDERED, That Mr. Stevens, Mr. Seth and Mr. Sudler, be a committee to prepare and bring in the same.
