The bill to fix and establish the pay of the adjutant-general and brigade inspectors, the bill authorising the levy court of Washington county to appoint commissioners to review the road therein mentioned, the bill to provide for the transcribing of certain land records in Prince-George's county, and for making out an alphabet to the same, the bill for the preservation of the navigation of the north-west branch of Nanticoke river, in Dorchester county, the bill for the preservation of the navigation of Cabin creek, in Dorchester county, the bill authorising the court of chancery to decree in the case therein mentioned, the resolution in favour of the examiner-general, and the resolution relative to the militia law, were sent to the senate by the clerk.

The report of the committee on the petition of Bennett Hamilton and Charles Seweil, was read the second time, and the question put, That the following words be stricken out of the resolution therein contained? "and that they the said Bennett Hamilton and Charles Sewell, be and they are hereby empowered and permitted to take out an execution or executions for the sum of money already by them paid, in the same manner that they might or could have done if they had paid the whole of the debt to the said state against the said Charles

Mankin, and the other securities of the said Charles Mankin." Determined in the negative.

The question was then put, That the house concur with the said report, and assent to the resolution therein contained? Resolved in the affirmative.

The house resumed the consideration of the bill to prevent for a limitted time the sale of lands or tenements, goods or chattels, on writs of execution, and for other purposes therein mentioned; which being read throughout, the question was put, Shall the said bill pass? The year and nays being required, appeared as follow:
