Mr. Mitchell, from the committee, delivers to the speaker the following report:

THE committee to whom was referred the petition of Archibald Gordon, of Cecil county, late a brave and worthy soldier in the revolutionary war, report, that they have had the same under consideration, and find from ample testimony, to wit, from the certificate of Hezekiah Ford, brigadier-general, and from other old and respectable citizens, that he was a citizen of the state of Maryland, and a brave and good soldier during the revolutionary war; that he now labours under a very severe disease, the effect of the great exposure, fatigue and labour, which he experienced in fighting the battles of his country, which secured liberty and independence to America, from which he is rendered unable, in his advanced age, to procure a support for himself and family; with this view of his case, your committee, under the impression that it becomes the peculiar duty of a dignified state, whose treasury abounds with wealth, to provide for the unfortunate and meritorious soldier who spent the prime and vigour of his life in fighting her battles and in procuring her rights, recommend the following resolution:
