The bill for recording certain wills in the register's office of Worcester county, was read the second time and

The report on the petition of John Wilkins was read the second time, and the resolution therein contained assented to.

The further supplement to the act, entitled, An act relating to the public roads in Queen-Anne's county, was

read the second time and passed.

On motion, the house resolved itself into a committee of the whole, on the bill to regulate and discipline the militia of this state; Mr. Hawkins in the chair. After sometime spent therein, the speaker resumed the chair, and Mr. Hawkins reported, that the committee had taken into consideration the subject matter referred to them, and had made several amendments, and reported the said bill, with the amendments.
