Mr. Seth, from the committee, delivers to the speaker a bill, entitled, An act to alter all such parts of the constitution and form of government of this state as relate to voters and qualification of voters; which was read

the first time and ordered to lie on the table.

Mr. Bowles, from the committee, delivers to the speaker a bill, entitled, An act for the relief of George Rutter, of Washington county; which was read the first time and ordered to lie on the table.

Mr. Randall, from the committee, delivers to the speaker a bill, entitled, An act to lay out and straighten a

xoad in Baltimore county; which was read the first time and ordered to lie on the table.

The bill authorising a lottery to raise a sum of money for the purpose of repairing the parsonage-house and the church belonging to the German evangelical lutheran congregation in Frederick-town, in Frederick county, and the bill for the relief of petit jurors of Baltimore county court, were read the second time and passed.
