

This Indenture made this nineteenth day of May in the twelve years
 of my Dominion of my Right Honourable Charles Blounte Lord Proprietary
 of the provinces of Maryland & New-England, Lord Baron of Dartmouth, and
 in the year of our Lord Christ one thousand six hundred Eighty, and
 fourteen, one and Bottnon Michael Miller of the County of Kent planter
 of my own parte and William Pearce of his same County planter of his other
 parte witnesseth that hee by said Michael Miller doth for consideration
 of the sum of fifteen thousand pounds of good tobacco to him herein payd
 off or before the nexting & delivery of these presents the receipt whereof
 by said Michael Miller doth acknowledge himselfe fully satisfied and
 Contented and payd and thdroft and of every parte of percell thereof
 doth Exonorate Squitt and Discharge by said William Pearce his
 heires & Adm^r & Assignes for ever hath Bargained sold let & ffreed
 and Confirmed and doth by these presents bargaine sell alienate
 Enfeoffe & Confirm unto to said William Pearce his heires & Assignes
 for ever all that tract or percell of Land being parte of a tract of land lying
 in Kent County and in Abey Cottrell Langfords Bay begining at a bounded
 tree of a parcell of land belonging to Richard Hudson being upon a hundred
 acres of his said Hudsons Land and running upon his said Bay for breadth fifty
 perches from them north west four hundred feet longt^t to a iron post
 of his neare west line south west fifty perches unbill^d to a post in said
 Hudsons Land & thence along the said Hudsons line to his south bounder
 tree containing one hundred twenty five acres by his same meadow
 lopt together with all & singular his Rights members & appendages, priuile
 ges or profitts thereunto belonging or in any wise appertaining
 with all dodos wrightings & evidences in Manuscripts touching or in any
 wise concerning his same to have and to hold the said tract or percell
 of Land withall and singular the Office Bargained promises unto him
 by said william Pearce his heires and assignes for ever and by said
 Michael Miller doth for himselfe his heires & Adm^r hereby
 Covenant promise to and with by said William Pearce his heires
 or assignes that hee by said Michael Miller his heires & Adm^r or
 assignes the said tract or percell of Land with all & singular his belon
 gaged promises unto him by said william Pearce his heires &
 or assignes shall and will at all times hereafter for ever warrant
 and defend from all manner of persons laying any claim right
 or title thererunto the rents & services due unto his Lord proprie
 tory only Excepted & reserved In lesse money whereof I do herewith
