C H A P. LXXIII.

An ACT to correct a mistake in the beginning of lot number three Passed 31st of Dec. 1801. thousand two hundred and eighty-seven of the lands lying westward of Fort Cumberland.

HEREAS it is represented to this general assembly, by the petition of John Simkins, that Preamble. a patent has been granted to him for a lot of land lying westward of Fort Cumberland, distinguished on the plot by lot number three thousand two hundred and eighty-seven, and that the surveyor in making a return of the courses of the said lot has represented the same to begin at the end of the first line of lot three thousand two hundred and eighty-six, instead of beginning at the end of the first line of lot three thousand two hundred and eighty-five; and the facts stated in the said petition appearing to be true, therefore,

II. BE IT ENACTED, by the General Assembly of Maryland, That the register of the land-office for Mistake to be the western shore be and he is hereby authorised, empowered and directed, to correct the mistake corrected, &c. made by the surveyor in his return of the courses of the said lot number three thousand two hundred and eighty-seven, by altering the said return, and also to correct the patent for, and record of, the same, so as to make the said lot begin at the end of the first line of lot number three thousand two hundred and eighty-five, instead of beginning at the end of the first line of lot three thousand two hundred and eighty-six, as it now stands; provided, that nothing herein contained shall affect the right of any other person.

C H A P.

An ACT relative to the administration of justice in this state, and Passed 31st of Dec. 1801. to repeal the acts of assembly therein mentioned.

E IT ENACTED, by the General Assembly of Maryland, That this state shall be divided into five State divided districts, to be numbered and distinguished as follows; that is to say, Saint-Mary's, Calvert, into diffricts. Prince-George's and Charles counties, shall be the first district; Cæcil, Kent, Queen-Anne's and Talbot counties, shall be the second district; Anne-Arundel, Baltimore and Harford counties, shall be the third district; Caroline, Dorchefter, Somerset and Worcester counties, shall be the fourth district; and Washington, Frederick, Montgomery and Allegany counties, shall be the fifth district.
