Crain, Judge.—Composed of the counties of St. Mary's, Charles and Prince George's. *St. Marus*, Leonardtown, 1st Monday in March and August. *Charles*, Port Tobacco, 3d Monday in February and July. *Prince George's*, Upper Marlborough, 1st Monday in April and November.**SECOND JUDICIAL CIRCUIT.**—Nicholas Brewer, Judge.—Composed of the counties of Anne Arundel, Howard Dist., Calvert and Montgomery. *Anne Arundel*, Annapolis, 3d Monday in April and 4th Monday in October. *Howard District*, of A. Arundel co., 2d Monday in March and 3d Monday in September. *Calvert*, Prince Fredericktown, 2d Monday in May and October. *Montgomery*, Rockville, 1st Monday in March and 2d Monday in November.**THIRD JUDICIAL CIRCUIT.**—Madison Nelson, Judge.—Composed of the Counties of Frederick and Carroll. *Frederick*, Frederick City, 4th Monday in February and October. *Carroll*, Westminster, 1st Monday of April and September.**FOURTH JUDICIAL CIRCUIT.**—Thomas Perry, Judge.—Composed of the Counties of Alleghany and Washington. *Alleghany*, Cumberland, 3d Monday in April and 2d Monday in October. *Washington*, Hagerstown, 4th Monday in March and 3d Monday in November**FIFTH JUDICIAL CIRCUIT.**—Three Courts.—William Frick, Judge of the Superior Court, William L. Marshall, Judge of the Court of Common Pleas, Henry Stump, Judge of the Criminal Court.—Composed of the City of Baltimore. The Criminal Court has three regular terms in the year, commencing as follow, viz: the 2d Monday in January, 3d Monday in May, and 2d Monday in September. The *Orphans' Court* sits every day except Sundays and holidays.**SIXTH JUDICIAL CIRCUIT.**—Albert Constable, Judge.—Composed of the Counties of Baltimore, Harford and Cecil. *Baltimore county*, Baltimore for City Civil business, 2d Monday of January, 3d Monday of May and 2d Monday of September.
