And the afo Elizabeth Carr in her proper person comes and saith that she cannot deny the Indictment afo so as afo against her brought nor that she is guilty of the premises afo above upon her Imposed by permitting a Negro man to have carnal knowledge of her Body and to begott her with Child of a bastard Mulletto as in the afo Indictment it is alledged and thereupon Submits to the Court Therefore it is ordered by the Justice here to wit All the Court House in the Town of Chester in Kent County on the third day of March being the seventeenth day of said Month Anno Domini Seventeen Hundred and Twenty Nine That the afo Elizabeth Carr being a Slave shall serve her time of Service and then shall serve her Master four Months longer for the Damage that the said Master shall sustain on afo of the afo Elizabeth being begott with Child by a Negro as afo as by her Confession afo and also at the Expiration thereof shall serve to the use of the County for and during the Term of Seven Years as a punishment for Committing the offence afo according to Act of Assembly in such Case made and provided and also pay the sum of one hundred and twenty eight pounds of Tobacco left accruing on the premises afo

ordered by the Court here that the said Elizabeth Carr be delivered up to this Court at the Expiration of her time to be disposed for the above Seven years
