 Prop^r in the Sum of twenty pounds sh^d to be levoyd on his Body Goods and Chattel
 Land and Tenements Conditionally to the use of his said Lord Ship his Heir and Successor
 Conditionally that if he shall not make his p^offsonall appearance at the next Court
 to be held for said County on the third Tuesday in June next to answer unto what
 shall be objected against him on his behav^r being supposed of a certain felony and
 that in the mean time he is to be of good behav^r wherewith he acknowledges himselfe
 content and also at the same time came a certain Ellis Fouze of the sd County Planter and
 in his prof^offson acknowledges himselfe Indebted to the Right Hon^{ble} the Lord Prop^r in
 the Sum of twenty pounds sh^d to be levoyd on his Body Goods and Chattel Land
 and Tenements to the use of his said Lord Ship his Heir and Successor Conditionally that if
 the sd Joseph Sanders shall not make his p^offsonall appearance at the next Court to be
 held for said County on the third Tuesday in June to answer unto what shall be objected
 against him on his being supposed of a certain felony and that in the meantime the same
 Joseph Sanders is to be of good behav^r wherewith the said Ellis Fouze acknow-
 ledges himselfe to be therewith content

Thomas Hatcher of said County is ordered to ent^r into recognizance at an-
 ord^d against the sd Joseph Sanders and thereupon the same Thomas Hatcher
 in his prof^offson comes into Court and acknowledges himselfe Indebted to the Right
 Hon^{ble} the Lord Prop^r in the Sum of ten pounds sh^d to be levoyd on his Body Goods
 and Chattel Land and Tenements to the use of his said Lord Ship his Heir and Successor
 Conditionally that if he do not appear at the next Court to be held for said County to give
 his Lord or his Majesty's behav^r against the sd Joseph Sanders wherewith he
 acknowledges himselfe to be therewith content

His Majesty } The sd John Howell is ord^d to enter into recognizance wth
 John Howell } Security for his appearance to next Court
 Thereupon comes into Court the sd John Howell and in his
 proper person acknowledges himselfe Indebted to the Right
 Hon^{ble} the Lord Prop^r in the Sum of twenty pounds sh^d
 to be levoyd on his Body Goods and Chattel Land and Tenements to the use of his
 said Lord Ship his Heir and Successor Conditionally that if he do not make his
 p^offsonall appearance at the next Court to be held for said County on the third Tuesday
 in June next to answer unto what shall be objected against him on account of his
 attempting to ravish a certain Mary Noale and in the mean time he is to be of
 good behav^r wherewith he acknowledges himselfe content

and also at the same time came a certain Benjamin Holley of the sd County
 Planter and acknowledges himselfe Indebted to the Right Hon^{ble} the Lord Prop^r
 in the Sum of twenty pounds sh^d to be levoyd on his Body Goods & Chattel Land
