Thomas Gresham } Jurors of the Substanti of the County by the sd Thomas
and the Court being informed of the Same The Court orders that Joseph Young Sheriff of Said Real County bring the Same Thomas immediately before the Court to answer the Same Thereupon afterwards the Same Sheriff came and made return of his Said war. order & that he had the Said Thomas Gresham before the Court. And the sd Thomas in his proper person appeared before the Court and by the Court it is ordered that the Same Thomas enter into Recognizance for his appearance at any time during this Court sitting and in the mean time he is to be of good behav. &c.

And the sd Thomas Gresham in his proper person here present in Court comes and acknowledges himselfe indebted to the Right Hon. ^{the} Lord property in the Summe of ten pounds Sterling money to be Levied on his Body Goods & Chattels Lands and Tenements to the use of his Said Lord Ship his heirs and Successors Conditionally that if he shall not make his personall appearance at any time during this Courts sitting and to answer unto what shall be objected against him on auct. of an assault committed in the Court House yard against a certain William Woley and in the mean time he is to be of good behav. wherewith he acknowledged himselfe to be therewith content

H. His Ship } W. William Graves of this County here present in Court
Thomas Gresham } comes and makes Complaint against the Same Thomas Gresham for assaulting him who being called appears in his proper person. and the Same William Graves being Sworn generally to declare the manner Saith the Same Thomas doubled his fist and held it up and ran it to his face and told him the said William he would whip his dogge therein with severall other prooking words

Mr. Joseph Young of Said County being Sworn as afo Declares to the Same purpose that the Court doth here order. that the Same Thomas Gresham doth ent. into Recognizance for his appearance to next Court and in the mean time he is to be of good behav. Thereupon the Same Thomas Gresham comes into Court and acknowledged himselfe indebted to the Right Hon. ^{the} Lord property in the Summe of fifty pounds Sterd to be Levied on his Body Goods and Chattels Lands and Tenements to the use of his Said Lord Ship his heirs and Successors Conditionally that if he the Same Thomas shall not make his personall appear. at the next Court to be held for Said County on the third Tuesday in August next ensuing And that in the mean time he is to be of good behav. wherewith he acknowledged himselfe content

At the Same time came John Gresham of Said County Gent and here present in Court and acknowledged himselfe indebted to the Right Hon. ^{the} Lord property in the Summe of fifty pounds Sterling to be Levied on his Body Goods and Chattels Lands and Tenements
