 of this Court did commit Fornication with Rachel Bostick and then and there  
 did begit a bastard Child on the body of her the same Rachel to the high displeasure  
 of Almighty God to the evil example of all others in such case offending contrary  
 to the peace of the said Lord Proprietary his good rule and Government and against  
 the form of the Act of Assembly in such case lately made and provided

The same Indulment was endorsed by the said James Moore foreman  
 The said James at this Court to wit the third Tuesday in November being the  
 twenty first day of said month Anno Domini Seventeen hundred and thirty two came  
 the said James Boyer and in his proper person appeared to the said Indulment  
 and now here the said Lord Proprietary by James Francis Esq of the Indulments  
 of this Court saith that there is not evidence to support the charge in the said  
 Indulment or which the Court make inquiry therein and appearing to be true the  
 Court orders a Nolle prosequi to be entered to the same Therefore it is  
 Considered by the Justice here to wit the same day last mentioned that the said  
 James Boyer as to the said Indulment do go thereof with good day and that he be  
 therefrom acquit and also it is Considered that the said James pay the  
 sum of two hundred and two pounds of Tobacco costs accruing on the premises  
 aforesaid to the officers of this Court

Ordered by the Court here that John Grosham Gent Sheriff of said County  
 keep the said James in safe custody until an other Indulment be made and  
 filed against him
