 did commit Fornication with a certain person to the Jurors aforesaid unknown and did  
 permit the same unknown person then and there to have carnal knowledge of her  
 body and to beget then and there two bastard Children on the body of her the  
 same Mary to the high displeasure of almighty God to the evil Example of  
 all others in such case offending contrary to the peace of the said Lord Proprietary  
 that now is his good Rule and Government & against the form of the Act of  
 Assembly in that case made and provided  
 That the same Judgment was ordered by Bill of  
 Francis God part.

And the aforesaid Mary Ryley in her petition comes and saith that she cannot pay  
 the Judgment of Court against her brought nor that she is guilty of  
 the premises about upon her imposed as by the aforesaid Judgment it is alleged  
 and whereupon submits to the Court therefore it is considered by  
 the Justices here to wit at Court County at the Court house in the Town of New York  
 in said County on the third Tuesday in March being the twentieth day of said Month  
 Anno Domini One Thousand Seven hundred and thirty two that the aforesaid Mary  
 Ryley pay the sum of thirty Shillings Current money of the Province aforesaid  
 as a fine for the welfare of the aforesaid County for committing the Fornication aforesaid in  
 form aforesaid and also pay the sum of three hundred and twenty  
 five pounds of Tobacco costs accruing on the premises  
 aforesaid to the officers of this Court

ordered by this Court that surely be given for the fine aforesaid and for  
 thereupon William Santhorn of Court County Planter present in Court in  
 his proper person and Acknowledges himself indebted to the Right Hon<sup>ble</sup>  
 the Lord Proprietary in the sum of thirty Shillings Current money of the Province  
 of Maryland to be made and levied upon all his body goods and chattels  
 Lands and Tenements to the use of the aforesaid County to be paid at or before  
 the tenth day of November next ensuing and also <sup>pay</sup> all the fees  
 accruing to the officers of this Court on the premises aforesaid

It is ordered by this Court that the aforesaid Mary give surely to  
 appear at any time during this Court sitting to answer or aforesaid
