Lord Proprietary that now is in the sum of five pounds Sterling money of
great Brittain to be made and levied on his body goods and Chattels Lands and
Tenements to the use of the said Lord Proprietary his heirs and Successors conditionally
that if he do not make his personall appearance at the next Court to be holden
for said County at the Court House in the Town of Chester in said County on the third
Wednesday in August then next ensuing to give his evidence on behalf of his said
King against the said John English and not to depart the said Court without
leave wherewith the said Peter Cawarding acknowledged
himself Content
