The Jurors for the Right Honourable the Lord Propy that now is for the body of Kent County upon their oath do present that Pharaoh Mingo late of the said Parishes in the County afe Labourer the tenth day of October Anno Domini 1733: soon hundred thirty three with force and Arms at the parish afe in the County. afe within the Jurisdiction of this Court one pen knife of the value of ten pounds of tobacco and one pair of Shirt Sleeve buttons made of Silver of the value of Twenty pounds of Tobacco of the goods and Chattels of a certain John Gillylean then and there being found therein there solemnly did steal take and bear away contrary to the Peace of the said Lord Propy that now is his good rule and Government and against the form of the Act of Assembly in such case lately made and provided

And the afe Pharaoh Mingo being called appeared to the afe Indictment and the afe Pharaoh Mingo in his proper person cometh and Saith that he cannot ~~gainsay~~ the Indictment afe does afe against him brought up but that he is ~~guilty~~ ^{Submits} of the premises above upon him imposed as by the afe Indictment it is alleged and thereof he ~~pleads~~ ^{Submits} himself afe the Court

Therefore ~~it is considered~~ ^{Pharaoh Mingo is of the} by the Justices here to wit at Kent County at the Court House in the Town of Chester in said County on the third Tuesday in November being the twentieth day of said Month Anno Domini one thousand seven hundred and thirty three That the afe Pharaoh Mingo for committing the felony afe as afe Confess said one hour in the pillory and to have on his bare back twenty one Lashes well laid on till the blood appear and also pay the four fold of the afe goods of the value of twenty pounds of Tobacco the four fold of which amounts to eighty pounds of Tobacco to be paid to the afe John Gillylean and also it is considered That the afe Pharaoh Mingo pay the sum of seven hundred and Ninety three pounds of Tobacco wth accruing on the premises afe to the officers of this Court

It is also considered by the Court here at this day to wit the day and year last mentioned That the Sheriff of Kent County take the afe Pharaoh Mingo into his Custody and execute the punishment in the Judgment afe Specific and afterwards to bring him into Court again of which precept to wit John Gresham Gent High Sheriff of Kent County makes Return on the day of year last said That he hath executed the punishment in the Judgment afe and also hath here the said Pharaoh Mingo before the Court

Samuel Fleming being an Evidence in the afe cause comes into Court and prays an allowance for two days allowance Thereupon being sworn Saith that he attended this Court as an Evidence two days. ordered by this Court that the afe Pharaoh Mingo pay to the afe Samuel Fleming the sum of Sixty pounds of Tobacco for his two days allowance as afe
