

To the bequests of One Thousand Dollars (\$1,000) each to the Vestry of Emmanuel Parish of the Protestant Episcopal Church, Cumberland, Maryland; the Allegany County Tuberculosis Sanitarium, and to Reverend Father Andrew J. Conlon, Chaplain for the Christian Brothers, Amendale, Maryland, contained in the will of Mary C. Caton, deceased of Allegany County, Maryland. Simpson and Laura E.
