Applegarth, late of Baltimore City, deceased, duly admitted to probate by the Orphans' Court of Baltimore City on October 15, 1930, and recorded in the office of the Register of Wills of Baltimore City in Wills Liber E. R. D. No. 168, folio —.

To the bequests contained in the last will and testament of George C. Thomas, late of Baltimore City, deceased, duly admitted to probate by the Orphans' Court for Baltimore City and recorded in the office of the Register of Wills of said city in Wills Liber E. R. D. No. 168, folio 73, etc., as follows:

(a) To the Vestry of the Protestant Episcopal Church of St. Michael and All Angels of Baltimore City, the sum of \$10,000;
