Shower, deceased, said will being probated by the Orphans' Court for Carroll County on November 4, 1929, and recorded in the office of the Register of Wills of Carroll County in Will Record W. F. B. No. 13, folio 524, the sum of one hundred dollars* (\$100).

To the bequests contained in the last will and testament of John F. B.
