

To the bequests contained in the last will and testament of Mary Sanders, late of Baltimore City, deceased, duly probated by the Orphans' Court for Baltimore City and recorded in the office of the Register of Wills for Baltimore City aforesaid, in Wills Liber E. R. D. No. 162, folio 256, etc., as follows:

(1) To the Tressler Orphan Home, Loysville, Pennsylvania, one hundred dollars (\$100);

(2) To the Inner Mission Society of the Lutheran Church, Baltimore, one hundred dollars (\$100).

To the conveyance contained in a Deed for the acquisition of the property at the northeast corner of Caroline and Eager Streets, Baltimore City, under a Contract of Sale by the Trustees of Madison Square Centenary Methodist Episcopal Church in the City of Baltimore to The Most Reverend Michael J.
