House Bill No. 69—By Mr. Lee:

A Bill entitled "An Act to repeal Section 91 (h) of Article 66½ of the Annotated Code of Maryland (1957 Edition), title 'Motor Vehicles', sub-title 'Administration—Registration—Titling', and to enact in lieu thereof new Section 91 (h), to follow immediately after Section 91 (g) of said Article, relating to the issuance of motor vehicles drivers' licenses to deaf persons".
