INTRODUCTION OF BILLS

House Bill No. 1—By The Speaker:

A Bill entitled "An Act to authorize the Mayor and City Council of Baltimore to issue the certificates of indebtedness of said corporation to an amount not exceeding Six Million Dollars (\$6,000,000), the proceeds of the same to be used for the acquisition of land or property in the City of Baltimore and establishing, constructing, erecting and equipping on said land or property, or on any land or property now or hereafter owned by the Mayor and City Council of Baltimore, a modern and adequate civic center and all facilities and appurtenances necessary or useful in connection with the operation of a modern civic center which shall be designed and constructed to be used for or in connection with sporting events, exhibitions, performances for theatrical, educational and cultural purposes and for a public auditorium or convention hall, and for doing any and all things necessary, proper or expedient in connection with or pertaining to
