Individuals in-Section 1. Be it enacted by the General Assembly of Maryland, That John R. Rhodes, William T. Draper, corporated Thomas Denmeod, William Kirby, Henry Walker, John B. Mears, George Waterson, Jacob Gruber, Leonard Forest, and others, who now are or may hereafter become members of said society, and their successors, are hereby declared to be one community and body corporate, by the
