And be it enacted, That if the owner or owners disability of the of any lands sold under this act, shall at the time of sale be under the impediment of coverture, infancy, insanity of mind, actual imprisonment, or be residing beyond the limits of the United States, he, she or they shall have until within one year after the diability or disabilities are removed, to redeem such land or lands by paying or tendering to the purchaser or purchasers thereof, his, her or their heirs or assigns, the purchase money and all legal costs, together with an interest of six per cent per annum on the amount, and also the value of all improvements made on such land or lands since the day of sale; and upon the payment of the same or tendering payment thereof, the purchaser or purchasers of his, her or their heirs or assigns, shall immediately reconvey all such land or lands to the original owner or owners thereof, his, her or their heirs or by the said second section thereof. assigns.
