CHAPTER 50.

Passed Feb 1 1842. *An act supplemental to an act entitled, an act to incorporate a company to make a Turnpike Road from some point on the National Road, west of Cumberland, to intersect the Northwestern Turnpike Road of Virginia, at some point in Allegany County.*
