C H A P. LIX. An ACT to lay out, straighten and confirm, a certain road in Har- Passed 20th of January, 1808. ford county.

HEREAS it is represented to this general assembly, by the petition of sundry inhabitants of Preamble. Harford county, that the convenience of the public will be greatly promoted by straightening and amending the road now used, leading from Josias Carvill Hall's land, by Charles Rigden's milf, until it intersects the road leading to Smith's ferry at or near a place known by the name of The Quaker Bottom; therefore,

II. BE IT ENACTED, by the General Assembly of Maryland, That Roger Boyce, Paca Smith and Tho- Commissioners mas Mitchell, be and they are hereby appointed commissioners, and they, or a majority of them, appointed, &c. are hereby authorised and empowered to view, lay out, straighten and confirm, a certain road now leading from Josias Carvill Hall's land, in Harford county, until it intersects the road leading to Smith's ferry on the Susquehanna, not exceeding twenty-six feet in width, beginning at the north end of the first lane on the road leading from Crispin Cunningham's to the lower cross roads in Harford county, thence to Charles Rigden's mill, thence between the lands of Benjamin Fletcher and Charles Rigden, and thence with the old road, straightening and amending the same until it intersects the road leading to Smith's ferry at or near a place called and known by the name of The Quaker Bottom, on the best ground, and with the least possible injury to the person or persons through whose land the same may pass; provided, that the said road shall not go through the yards, gardens or orchards, of any person or persons, without his, her or their consent.



III. AND BE IT ENACTED, That the said commissioners, or a majority of them, are hereby re- A plot to be quired to return a plot of said road to the clerk's office of said county, there to be recorded, together returned, &s. with an estimate of the damages, if any, sustained by any person or persons through whose land the same may pass, and the levy court of said county shall, at their first meeting after the return of the said plot and estimate of damages, by warrant under their hands and seals, appoint an overseer to open and clear said road, agreeably to said plot, in the same manner as other roads are opened and cleared, and the overseer shall have the same allowance for his services as other overseers in said county.

IV. AND BE IT ENACTED, That the levy court of Harford county are hereby empowered and Court to levy directed to assess and levy such sum of money as they in their judgment shall deem necessary to money, &c. open and clear such road, which said sum of money shall be collected and paid over as other county charges.
