EACH SUPERVISOR OF ELECTIONS APPOINTED UNDER SECTION 1 (a) OR SECTION 1 (c) OF THIS AR-TICLE SHALL RECEIVE AN ANNUAL SALARY AS FOL-LOWS: IN ALLEGANY COUNTY, \$900; IN ANNE ARUN-DEL COUNTY, \$800: IN BLTIMORE CITY, \$3,190 UNTIL JANUARY 1, 1950, AND THEREAFTER \$5,000; IN BALTI-MORE COUNTY, \$1,800; IN CALVERT COUNTY, \$200; IN CAROLINE COUNTY, \$300: IN CARROLL COUNTY, \$400; IN CECIL OUNTY, \$300; IN CHARLES COUNTY, \$250; IN DORCHESTER COUNTY, \$400; IN FREDERICK COUNTY, \$480: IN GARRETT COUNTY, \$300: IN HARFORD COUN-TY. \$400: IN HOWARD COUNTY, \$400; IN KENT COUNTY, \$400: IN MONTGOMERY COUNTY, \$1,200; IN PRINCE GEORGE'S COUNTY, \$1,000; IN QUEEN ANNE'S COUN-TY, \$300; IN ST. MARY'S COUNTY, \$250; IN SOMERSET COUNTY, \$300; IN TALBOT COUNTY, \$250; IN WASHING-TON COUNTY, \$600; IN WICOMICO COUNTY, \$400; IN WORCESTER COUNTY, \$300. SUCH SALARIES AND ANY OTHER EXPENSES INCURRED BY SAID SUPER-VISORS UNDER THIS ARTICLE, SHALL BE PAID BY THE COUNTY COMMISSIONERS OF THEIR RESPEC-TIVE COUNTIES OR BY THE MAYOR AND CITY COUN-CIL OF BALTIMORE CITY, AS THE CASE MAY BE, IN SUCH INSTALLMENTS AS THE SAID COUNTY COM-MISSIONERS OR MAYOR AND CITY COUNCIL MAY PRE-SCRIBE, AND THEY SHALL RECEIVE NO OTHER FEES OR COMPENSATION, EXCEPT AS HEREINAFTER PRO-VIDED. EACH SUBSTITUTE SUPERVISOR APPOINTED UNDER SECTION 1 (b) OF THIS ARTICLE SHALL RE-CEIVE A PER DIEM COMPENSATION OF NOT LESS THAN TEN DOLLARS (\$10) PER DAY FOR EACH DAY ACTUALLY SERVED BY HIM, TO BE FIXED BY THE COUNTY COMMISSIONERS OF THE RESPECTIVE COUN-TIES OR THE MAYOR AND CITY COUNCIL OF BALTI-MORE CITY, AS THE CASE MAY BE. IN WICOMICO COUNTY THE CLERK OF THE BOARD OF SUPERVI-SORS OF ELECTIONS PROVIDED FOR IN THIS AR-TICLE SHALL RECEIVE AN ANNUAL SALARY OF \$400, AND THE SAID SUPERVISOR OF ELECTIONS SHALL HAVE POWER TO EMPLOY AN ATTORNEY, WHO SHALL BE A MEMBER OF THE BAR OF WICOMICO COUNTY AND WHO SHALL ALSO BE THE ATTORNEY FOR THE JUDGES OF ELECTIONS, AND SUCH ATTOR-NEY SHALL RECEIVE AN ANNUAL SALARY OF \$400; THE SALARIES OF SAID CLERK AND SAID ATTORNEY TO BE PAID IN EQUAL QUARTERLY INSTALLMENTS BY THE COUNTY COMMISSIONERS OF WICOMICO COUNTY; PROVIDED, HOWEVER, THAT IN THE EVENT
