

ERAGES EXCEPT BEER, IN SEALED PACKAGES OR CONTAINERS, WHICH PACKAGES OR CONTAINERS SHALL NOT BE OPENED NOR THEIR CONTENTS CONSUMED UPON THE PREMISES WHERE SOLD. THE SAID BOARD ALSO SHALL ESTABLISH AND MAINTAIN A STORE TO BE LOCATED ON THE PROPERTY OWNED BY THE COUNTY COMMISSIONERS OF DORCHESTER COUNTY AND SITUATED ON A PLOT OF LAND BETWEEN DORCHESTER AVENUE AND SUNBURST HIGHWAY, SAID PLOT BEING APPROXIMATELY AT THE INTERSECTION OF THE PROPOSED CEDAR STREET EXTENSION AND LYING PARTLY WITHIN THE CORPORATE LIMITS OF CAMBRIDGE AND PARTLY OUTSIDE SUCH LIMITS; AND SAID STORE SHALL BE SUBJECT TO THE SAME PROVISIONS AND REQUIREMENTS AS THE STORE SPECIFIED HEREINABOVE IN THIS SUB SECTION.

148D. (a) All net profits arising from the operation of said dispensary shall be first applied towards the payment of any and all sums advanced to or borrowed by the Liquor Control Board. After such sums have been paid, the said Board shall be authorized to create and maintain a reserve fund not to exceed ~~[\$25,000]~~ \$50,000, including the total inventory of stock and supplies on hand, to provide adequate working capital and to meet any loss that may be sustained by the Board in the operation of said dispensary. ~~IN THE CITY OF CAMBRIDGE. THE SAID BOARD ALSO SHALL BE AUTHORIZED TO CREATE AND MAINTAIN A RESERVE FUND NOT TO EXCEED \$25,000.00, INCLUDING THE TOTAL INVENTORY OF STOCK AND SUPPLIES ON HAND TO PROVIDE ADEQUATE WORKING CAPITAL AND TO MEET ANY LOSS THAT MAY BE SUSTAINED BY THE BOARD IN THE OPERATION OF THE DISPENSARY LOCATED BETWEEN DORCHESTER AVENUE AND SUNBURST HIGHWAY; THE SAID BOARD IS AUTHORIZED TO BORROW SAID MONEY FROM THE COUNTY COMMISSIONERS OF DORCHESTER COUNTY IN ORDER TO ESTABLISH SUCH \$25,000.00 FUND.~~ All net profits in excess of the above requirements shall belong to and be paid over to the County Commissioners of Dorchester County on or before January 30th in each and every year.
