CHAPTER 569

(House Bill 416)

AN ACT to repeal and re-enact, with amendments, Section 1 of Article 2 of the Code of Public Local Laws of Mary land (1930 Edition), title 'Anne Arundel County". subtitle "Annapolis", as amended by Chapter 118 of the Acts of the General Assembly of Maryland, passed at its January Session in the year 1937, and Chapter 691 of the Acts of the General Assembly of Maryland, passed at its January Session in the year 1943, so as to prescribe the new boundaries of the City of Annapolis and to repeal and enact, with amendments. Sub-paragraph (f) of Section 274A of said Article 2 of the Code of Public Local Laws of Maryland, as said section was enacted by Chapter 106 of the Acts of the General Assembly of Maryland, passed at its February Session in the year 1950, so as to make the boundaries of the Sixth Election District of Anne Arundel County conform to the new boundaries of the City of Annapolis hereby provided for, and to repeal and re-enact, with amendments, Section 1 (b) of Chapter 691 so as to provide for the increase in the number of wards in the City of Annapolis, and the qualifictaion and salaries of the Mayor and Aldermen.

SUB-TITLE "ANNAPOLIS", SECTION 274A(F) HAV-ING BEEN ENACTED BY CHAPTER 106 OF 1950. PRE-SCRIBING THE NEW BOUNDARIES OF THE CITY OF ANNAPOLIS AND TO MAKE THE BOUNDARIES OF THE SIXTH ELECTION DISTRICT OF ANNE ARUN-DEL COUNTY CONFORM TO THE NEW BOUNDARIES OF THE CITY OF ANNAPOLIS, INCREASING THE NUMBER OF WARDS IN THE CITY OF ANNAPOLIS AND RELATING TO THE NOMINATION, QUALIFICA-TIONS AND SALARIES OF THE MAYOR AND ALDER-MEN OF THE CITY OF ANNAPOLIS.

WHEREAS, by Chapter 696 of the Acts of the General Assembly of Maryland, passed at its January Session in the year 1949, the Annapolis Annexation Charter Commission was created for the purpose of determining whether certain areas contiguous to the City of Annapolis should be annexed thereto; and
