

was enacted by Chapter 627 of the Acts of 1949, and relating to issuance of Class C Licenses in Wicomico County, FOR THE SALE OF LIQUOR IN CLUBS AND SUBMITTING THIS ACT TO A REFERENDUM.

AN ACT TO ADD TWO NEW SUB-SECTIONS TO ARTICLE 2B OF THE ANNOTATED CODE OF MARYLAND (1947 SUPPLEMENT), TITLE "ALCOHOLIC BEVERAGES", SAID NEW SUB-SECTIONS TO BE KNOWN AS SUB-SECTIONS 17 (L) AND 18 (I) OF SAID ARTICLE 2B; TO BE UNDER THE SUB-TITLE "BEER, WINE AND LIQUOR LICENSES", AND TO FOLLOW RESPECTIVELY AFTER SUB-SECTIONS 17 (K) AND 18 (HH) OF SAID ARTICLE AND SUB-TITLE, SUB-SECTION 18 (HH) HAVING BEEN ENACTED BY CHAPTER 627 OF THE ACTS OF 1949, RELATING TO THE ISSUE OF CLASS B AND CLASS C BEER, WINE AND LIQUOR LICENSES FOR HOTELS, RESTAURANTS AND CLUBS IN WICOMICO COUNTY AND MAKING THIS ACT SUBJECT TO A REFERENDUM.

Section 1. *Be it enacted by the General Assembly of Maryland,* That two new sub-sections be and they are hereby added to Section 17 and Section 18 of Article 2B of the Annotated Code of Maryland (1947 Supplement), title "Alcoholic Beverages", sub-titles "Beer, Wine and Liquor Licenses, Class B (On Sale)—Hotels and Restaurants", and "Beer, Wine and Liquor Licenses, Class C (On Sale)—Clubs", respectively, said new sub-section to Section 17 to be known as Sub-section (l) and to follow immediately after Sub-section (k) of said section as said Sub-section (k) appears in said Annotated Code of Maryland (1947 Supplement), and said new sub-section to Section 18 to be known as Sub-section (i) and to follow immediately after Sub-section (hh) of said section as Sub-section (hh) was enacted by Chapter 627 of the Acts of 1949, said new sub-sections to read, respectively, as follows:

LAND, THAT A NEW SUB-SECTION BE AND IT IS HEREBY ADDED TO SECTION 18 OF ARTICLE 2B OF THE ANNOTATED CODE OF MARYLAND (1947 SUPPLEMENT), TITLE "ALCOHOLIC BEVERAGES", SUB-TITLE "BEER, WINE AND LIQUOR LICENSES", SAID NEW SUB-SECTION TO BE KNOWN AS SUB-SECTION (I), TO FOLLOW IMMEDIATELY AFTER SUB-SECTION (HH) OF SAID SECTION 18, AS SAID SUB-SECTION WAS ENACTED BY CHAPTER 627 OF THE ACTS OF 1949, AND TO READ AS FOLLOWS:
