

ISTING SALARIES SUBJECT TO APPLICABLE REGULATIONS OF THE MONTGOMERY COUNTY PERSONNEL BOARD. THE COMMISSION SHALL PROMPTLY TRANSFER TO THE COUNTY MANAGER OF MONTGOMERY COUNTY ALL ITS BOOKS, RECORDS, PAPERS, DOCUMENTS, MAPS AND EQUIPMENT USED IN CONNECTION WITH THE FUNCTIONS TRANSFERRED. ALL FUNDS OF THE COMMISSION ON HAND ON THE DATE THE PROVISIONS OF THIS ACT TAKE EFFECT AND DERIVED FROM FEES COLLECTED BY SAID COMMISSION UNDER THE AUTHORITY CONFERRED BY THE SECTIONS REPEALED BY SECTION 1 OF THIS ACT, SHALL BE PROMPTLY PAID OVER TO MONTGOMERY COUNTY, AND SUCH FUNDS SHALL BE ALLOCATED BY THE COUNTY COUNCIL TO THE APPROPRIATE LOCAL GOVERNMENTAL AGENCIES FOR EXPENDITURE. NOTWITHSTANDING THE PROVISIONS OF THIS SECTION, THE APPROVAL OF THE MARYLAND-NATIONAL CAPITAL PARK AND PLANNING COMMISSION AS TO ZONING, SHALL FIRST BE OBTAINED, PRIOR TO THE ISSUANCE OF ANY BUILDING PERMIT.

SEC. 3. *AND BE IT FURTHER ENACTED*, THAT THE MARYLAND-NATIONAL CAPITAL PARK AND PLANNING COMMISSION AND MONTGOMERY COUNTY ARE HEREBY AUTHORIZED AND EMPOWERED TO ENTER INTO SUCH COMMITMENTS AND AGREEMENTS AS MAY BE NECESSARY TO EFFECTUATE THE TRANSFER FROM THE COMMISSION TO THE COUNTY OF THE ADMINISTRATION OF THE RECREATION PROGRAM HITHERTO CONDUCTED BY THE SAID COMMISSION WITHIN THE MARYLAND-WASHINGTON REGIONAL DISTRICT WITHIN MONTGOMERY COUNTY AND THE EXTENSION OF THE SAID PROGRAM THROUGHOUT MONTGOMERY COUNTY, PROVIDED THAT BEFORE ADMINISTRATION OF THAT PART OF THE SAID RECREATIONAL PROGRAM CONDUCTED WITHIN THE CAPPER-CRAMTON PARKS IS SO TRANSFERRED THE CONSENT AND APPROVAL OF THE NATIONAL CAPITAL PARK AND PLANNING COMMISSION SHALL FIRST BE OBTAINED.

SEC. 4. *AND BE IT FURTHER ENACTED*, THAT THIS ACT SHALL TAKE EFFECT NOVEMBER 1, 1951.
