- 9. TO THE BEQUEST, LEGACY OR DEVISE CONTAINED IN THE WILL OF FLORENCE M. MORGAN, LATE OF TALBOT COUNTY, DATED OCTOBER 20, 1943, AND DULY OF RECORD IN LIBER R. R. S. NO. 28, FOLIO 245, ONE OF THE WILLS RECORD BOOKS OF THE OFFICE OF THE REGISTER OF WILLS FOR TALBOT COUNTY, AS FOLLOWS:
