aforesaid line to its intersection at Forestville with a line 300 feet east of and parallel to the center line of the road leading southerly across the Washington and Marlboro Road into the Stewart Road: thence southerly about 0.1 mile along the aforesaid line to its intersection with a line 300 feet northeast of and parallel to the center line of the Washington and Marlboro Road; thence southeasterly and southerly about 2.3 miles along the aforesaid line of its intersection with the prolongation of a line 300 feet south of and parallel to the center line of the Meadows Camp $Springs\ Allentown\ Friendly\ Road;\ thence\ westerly\ and$ southwesterly about 3.2 miles along the aforesaid line to its intersection with a line 300 feet southwest of and parallel to the center line of the Southern Maryland Road, also known as the Brandywine Road; thence northwesterly about 2.8 miles along the aforesaid line extended to its intersection at Gordon's Corner with a line 300 feet west of and parallel to the center line of the continuation of the Southern Maryland Road; thence northerly about 0.5 mile along the aforesaid line to its intersection at Silver Hill with a line 300 feet southwest of and parallel to the center line of the Walker Road; thence northwesterly about 0.8 mile along the aforesaid line to its intersection with a line 2640 feet southeast of and parallel to the Maryland District of Columbia Boundary Line; thence due southwest about 6.6 miles along the aforesaid line to its intersection with the Maryland-Virginia Boundary Line: thence northerly about 0.7 mile along the aforesaid Boundary Line to its intersection with the Maryland-District of Columbia Boundary Line; thence due northeast 10.0 miles along the aforesaid Boundary Line to the eastern corner of the District of Columbia; thence due northeast 10.0 miles along the aforesaid Boundary Line to the northern corner of the District of Columbia; thence due southwest about 6.0 miles along the aforesaid Boundary Line to the place of beginning. 2-A-(1) THE AREA WITHIN THE SECOND PRE-CINCT OF ELECTION DISTRICT NO. 14 (BOWIE), OF PRINCE GEORGE'S COUNTY, IS HEREBY ADDED TO THE MARYLAND-WASHINGTON REGIONAL DIS-TRICT AS THE SAID DISTRICT WAS DEFINED BY CHAPTER 374 OF THE LAWS OF MARYLAND OF
