

*the Wilkins Estate, thence running with said division line in an Easterly direction to intersect the center line of the Baltimore and Ohio Railroad, thence running in a North-erly direction with said center line to the center line of Halpine Avenue, thence running in an Easterly direc-tion with the center line of Halpine Avenue to intersect the Southerly extension of the division line between the Sub-division of Twin Brook and the property of Robert A. Pugh, thence running in a Northerly direction with said division line, a distance of 200 feet, more or less, to the existing boundary line of the Washington Subur-ban Sanitary District as described above, thence running reversely with said boundary line in a generally Westerly and Southwesterly direction 200 feet distant from and parallel to the North line of Halpine Road, to the East line of Rockville Pike, U. S. Route No. 240, thence running due West to the place of beginning.*

**113 11A. THE BOUNDARIES OF THE TOWN OF ROCKVILLE ARE EXTENDED TO INCLUDE THE FOLLOWING AREA:**

**BEGINNING FOR THE SAME AT A POINT ON THE PRESENT CORPORATE LIMITS OF THE TOWN OF ROCKVILLE EXTENDING ACROSS THE WOOD-MONT COUNTRY CLUB, SAID POINT BEING 300 FEET, MORE OR LESS, WESTERLY FROM THE IN-TERSECTION OF SAID CORPORATE LIMIT WITH THE WEST LINE OF THE WASHINGTON ROCK-VILLE PIKE, U. S. ROUTE 240, AND RUNNING THENCE IN A SOUTHEASTERLY DIRECTION, 300 FEET WEST OF AND PARALLEL TO, THE WEST LINE OF SAID PIKE, TO INTERSECT THE DIVISION LINE OF THE AFORESAID WOODMONT COUNTRY CLUB AND THE CONGRESSIONAL AIRPORT PROP-ERTIES, THENCE RUNNING IN A SOUTHWESTER-LY DIRECTION WITH SAID DIVISION LINE A DIS-TANCE OF 620 FEET, MORE OR LESS, TO THE DIVI-SION LINE BETWEEN THE McKEEVER SHINN PROPERTY AND THE PROPERTY OF ARTHUR C. HYDE, THENCE RUNNING WITH SAID DIVISION LINE IN A SOUTHEASTERLY DIRECTION A DIS-TANCE OF 2300 FEET MORE OR LESS TO INTER-SECT THE NORTH LINE OF A 6.088 ACRE PARCEL, THE PROPERTY OF ARTHUR C. HYDE, 920 FEET MORE OR LESS FROM THE INTERSECTION OF SAID NORTH LINE WITH THE WEST LINE OF SAID WASHINGTON ROCKVILLE PIKE, THENCE CON-TINUING WITH AN EXTENSION OF SAID DIVISION**
