LINE, IN A SOUTHEASTERLY DIRECTION TO IN-TERSECT THE DIVISION LINE BETWEEN SAID 6.088 ACRE PARCEL AND THE COUNCELMAN BOUIC TRACT, THENCE RUNNING WITH SAID DIVISION LINE AND AN EXTENSION THEREOF. AN EASTERLY DIRECTION, ACROSS THE AFORESAID WASHINGTON ROCKVILLE PIKE TO THE SOUTHWEST CORNER OF THE SUBDIVISION HALPINE. THENCE RUNNING WITH THE SOUTH BOUNDARY LINE OF SAID SUBDIVISION IN AN EASTERLY DIRECTION. TO INTERSECT THE CENTER LINE OF THE BALTIMORE AND OHIO RAILROAD, THENCE RUNNING IN A NORTHWEST ERLY DIRECTION WITH SAID CENTER LINE TO A POINT THEREON 300 FEET, MORE OR LESS, SOUTHEASTERLY FROM THE CENTER OF HAL PINE ROAD, THENCE RUNNING IN AN EASTERLY DIRECTION. 300 FEET SOUTH OF AND PARALLEL TO THE CENTER LINE OF HALPINE ROAD, A DIS-TANCE OF 1800 FEET, MORE OR LESS, THENCE RUNNING IN A NORTHERLY DIRECTION AT RIGHT ANGLES TO SAID HALPINE ROAD, A DISTANCE OF 500 FEET, MORE OR LESS, TO INTERSECT THE PRESENT CORPORATE LIMITS OF THE TOWN OF ROCKVILLE.

ALL OF THE TERRITORY HEREBY ANNEXED TO THE TOWN OF ROCKVILLE SHALL BE EXCLUDED FROM THE LIMITS OF THE MARYLAND WASHING TON METROPOLITAN DISTRICT AND ALSO FROM THE LIMITS OF THE MARYLAND WASHINGTON REGIONAL DISTRICT. THE LANDS HEREIN DE-SCRIBED SHALL NOT BE SUBJECT TO THE MARY LAND NATIONAL CAPITAL PARK AND PLANNING COMMISSION NOR SUBJECT TO THE ORDINANCES THEREOF. ALL OF SAID LANDS SHALL HERE AFTER BE EXEMPT FROM TAXES HEREAFTER LEVIED FOR THE PURPOSES OF SAID METROPOLI-TAN AND REGIONAL DISTRICTS. ALL OF THE TERRITORY HEREBY ANNEXED TO THE TOWN OF ROCKVILLE SHALL FROM AND AFTER JUNE 1. 1953, BE SUBJECT TO ALL THE LAWS, ORDINANCES AND REGULATIONS OF SAID TOWN.

BEGINNING FOR THE SAME AT A POINT ON THE PRESENT CORPORATE LIMITS OF THE TOWN OF ROCKVILLE EXTENDING ACROSS THE WOOD-MONT COUNTRY CLUB, SAID POINT BEING 300 FEET, MORE OR LESS, WESTERLY FROM THE IN-
