

TERSECTION OF SAID CORPORATE LIMIT WITH THE WEST LINE OF THE WASHINGTON-ROCKVILLE PIKE, U. S. ROUTE 240, AND RUNNING THENCE IN A SOUTHEASTERLY DIRECTION, 300 FEET WEST OF AND PARALLEL TO, THE WEST LINE OF SAID PIKE, TO INTERSECT THE DIVISION LINE OF THE AFORESAID WOODMONT COUNTRY CLUB AND THE CONGRESSIONAL AIRPORT PROPERTIES, THENCE RUNNING IN A GENERALLY SOUTHWESTERLY DIRECTION WITH SAID DIVISION LINE SO AS TO INCLUDE SAID AIRPORT PROPERTY, TO THE MOST WESTERLY COMMON CORNER OF SAID WOODMONT CLUB AND AIRPORT PROPERTIES, THENCE CONTINUING WITH THE LINES OF SAID AIRPORT PROPERTY IN AN EASTERLY DIRECTION A DISTANCE OF 1184 FEET MORE OR LESS TO A CORNER OF SAID PROPERTY, THENCE RUNNING ACROSS SAID PROPERTY ON AN EXTENSION OF SAID LINE SO AS TO EXCLUDE A PART OF SAID PROPERTY, EASTERLY 400 FEET TO A CORNER THEREOF, THENCE AGAIN RUNNING WITH THE LINES OF SAID PROPERTY, EASTERLY 1322 FEET MORE OR LESS TO THE SOUTHEAST CORNER THEREOF, THENCE RUNNING WITH THE EAST LINE OF SAID AIRPORT PROPERTY A DISTANCE OF 968 FEET, MORE OR LESS, TO THE DIVISION LINE BETWEEN THE PROPERTY OF ARTHUR C. HYDE, FORMERLY THE JAMES H. WAGNER PROPERTY, AND THE PROPERTY OF COUNCELMAN AND BOUIC, THENCE RUNNING IN AN EASTERLY DIRECTION WITH SAID DIVISION LINE AND AN EXTENSION THEREOF, TO THE CENTER LINE OF THE SAID WASHINGTON-ROCKVILLE PIKE, U. S. ROUTE NO. 240, WITH AN EXTENSION OF SAID DIVISION LINE, IN A SOUTHEASTERLY DIRECTION TO INTERSECT THE DIVISION LINE BETWEEN SAID 6.088 ACRE PARCEL AND THE COUNCELMAN-BOUIC TRACT, THENCE RUNNING WITH SAID DIVISION LINE AND AN EXTENSION THEREOF, IN AN EASTERLY DIRECTION, ACROSS THE AFORESAID WASHINGTON-ROCKVILLE PIKE, TO THE SOUTHWEST CORNER OF THE SUB-DIVISION OF HALPINE, THENCE RUNNING WITH THE SOUTH BOUNDARY LINE OF SAID SUB-DIVISION, IN AN EASTERLY DIRECTION, TO INTERSECT THE CENTER LINE OF THE BALTIMORE AND OHIO RAILROAD, THENCE RUNNING IN A NORTHWESTERLY DIRECTION WITH
