## CHAPTER 639

## (Senate Bill 490)

AN ACT to repeal and re-enact, with amendments, Subsection (Prince George's County) of Section 100 of Article 52 of the Annotated Code of Maryland (1951 Edition), title "Justices of the Peace", sub title "Trial Magistrates System", relating to the places where the Trial Magistrates of Prince Goorge's County shall sit. AN ACT TO REPEAL AND RE-ENACT, AMENDMENTS, SUB-SECTION (D) OF SECTION 6 OF ARTICLE 52 OF THE ANNOTATED CODE OF MARYLAND (1951 EDITION), TITLE "JUSTICES OF THE PEACE", SUB-TITLE "CIVIL JURISDIC-TION". AND TO ENACT A NEW SUB-SECTION TO BE KNOWN AS SUB-SECTION (G) OF SAID SEC-TION, TO FOLLOW IMMEDIATELY AFTER SUB-SECTION (F) THEREOF; AND TO ADD TWO NEW SECTIONS TO SAID ARTICLE, SAID NEW SEC-TIONS TO BE KNOWN AS SECTION 29A AND SECTION 43A, SUB-TITLES "DOCKET", "PROCESS AND PRACTICE", RESPECTIVELY, AND TO FOLLOW IMMEDIATELY AFTER SECTIONS 29 AND 43 RESPECTIVELY; AND TO REPEAL AND RE-ENACT. WITH AMENDMENTS, SUB-SECTION (PRINCE GEORGE'S COUNTY) OF SECTION 100 OF SAID ARTICLE, SUB-TITLE "TRIAL MAGIS-TRATES SYSTEM"; AND TO ADD A NEW SEC-TION TO SAID ARTICLE AND SUB-TITLE, SAID NEW SECTION TO BE KNOWN AS SECTION 112A AND TO FOLLOW IMMEDIATELY AFTER SEC-TION 112 THEREOF, GENERALLY AMENDING THE LAW RELATING TO THE JURISDICTION, SALARY AND DUTIES OF THE TRIAL MAGIS-TRATES AND CLERKS TO THE TRIAL MAGIS-TRATES OF PRINCE GEORGE'S COUNTY.

Section 1. Be it enacted by the General Assembly of Maryland, That Sub-section (Prince George's County) of Section 100 of Article 52 of the Annotated Code of Maryland (1951 Edition), title "Justices of the Peace", sub-title "Trial Magistrates System", be and it is hereby repealed and re-enacted, with amendments, to read as follows:
