C H A P.

Supplement to an act, entitled, An act for the establishment of a Passed 25th of January, 1806. new public road in Somerset county, passed at November session, seventeen hundred and ninety-eight.

HEREAS it is represented to this general assembly, that a number of the inhabitants of Somerset county experience considerable in a second county experience county merset county experience considerable inconvenience from the want of said road, mentioned ad described in the original act, and have it not in their power, without some public assistance, to fray the costs and charges of the same; therefore,

II. BE IT ENACTED, by the General Assembly of Maryland, That the levy court of said county are creby empowered to assess and levy on said county, if they shall think fit, and it shall appear to cm that the said road, when opened, will be of public utility, a sum of money, not exceeding fifty illars, and cause the same to be paid to the commissioners named in the original act to which this a supplement, to be applied by them to the payment of the expences of said road.

C H A P. LXI.

n ACT to extend the powers of the trustees of the poor of Mont-Passed 25th of January, 1806. gomery county.

HEREAS John Randle, Ally Campbell and Rebecca Dennis, of Montgomery county, by their petitions to this general assembly have set forth, that by reason of many bodily infirities, and various other causes therein set forth, they are unable to obtain a livelihood by labour, and praying to be supported out of the poor-house of said county as out-pensioners; and the prayer the said petitioners appearing reasonable, therefore,

II. BE IT ENACTED, by the General Assembly of Maryland, That it shall and may be lawful for the ustees of the poor of Montgomery county, if they shall be of opinion that the peculiar circumances of the said John Randle, Ally Campbell and Rebecca Dennis, are such as to render a situaon in the poor-house particularly unsuitable for them, to support them as out-pensioners, in addion to the number now allowed by the act, entitled, An act to enlarge the powers of the trustees of he poor in the several counties therein designated, and to allow to the said John Randle, Ally ampbell and Rebecca Dennis, not exceeding thirty dollars each, to be paid at such time as the said justees shall direct, the amount of which said pensions shall be levied in the same manner as the ther expences of the poor-house in the said county; provided, that the application of the said John landle, Ally Campbell and Rebecca Dennis, to be supported as out pensioners as aforesaid, shall be commended by the levy court of said county.

> C H A P. LXII

Supplement to the act, entitled, An act to streighten part of the Passed 25th of January, 1806 road in Harford county which leads from Underhill's mill to the city of Baltimore.

HEREAS sundry inhabitants of Harford county, by their petition have represented to this general assembly, that the commissioners appointed under the original act to which this is a upplement, in taking a view of ground over which the road in the said original act mentioned was outemplated to pass, that it would be more advantageously laid out, to intersect at the Rock Ford, n the Little Falls, instead of intersecting at Hanway's mill, as provided in the said original act, nd praying that an act may pass appointing commissioners to make the alterations aforesaid on said oad, beginning near a place called and known by the name of The Sandy Bottom, on the road leadng from Coop's town to Hanway's mill, and to streighten and amend the said road until they interat the Rock Ford, on the Little Falls, with power to assess the damages; and the same being condered reasonable, therefore,

E
