CHAP. XXVII.

III. And BE IT ENACTED, That the expences arising in the execution of this act shall be paid Expences to be by the said Henry Hershberger.

XXVIII.

An ACT authorising Thomas Bailey, late sheriff and collector of Passed 31st of Dec. 1806. Baltimore county, to complete his collection, and for other purposes.

THEREAS it is represented to this general assembly, by the petition of Thomas Bailey, late Preamble sheriff and collector of Baltimore county, that from the multiplicity of business in his office, and other causes, he was unable to complete his collection within the time limitted by law, and astertain and make an annual return of insolvencies, so as to be allowed the same by the commissioners of the tax for Baltimore county, in consequence of which he is without remedy, unless by the interference of the general assembly; and the said Thomas Bailey having prayed that a law may bass, extending to him for a reasonable time, all the powers necessary to collect the balances due him as sheriff and collector, and to authorise the levy court to levy for him the sum of money which may appear to be due him, in consequence of payment made by him on the property of insolvents, is collector; therefore,

II. BE IT ENACTED, by the General Assembly of Maryland, That the said Thomas Bailey be and he T. Bailey ems hereby authorised and empowered, until the first day of January, eighteen hundred and eight, in powered tocols full and ample manner as he could have done during the time limitted by law, to collect all baances due him as sheriff and collector of Baltimore county for the year eighteen hundred and five, any law to the contrary notwithstanding.

III. And BE IT FURTHER ENACTED, That the levy court of Baltimore county be and they are Court may levy creby authorised and directed, at their next annual session for levying taxes on the said county, to money, &c. ery for the use of Thomas Bailey such sum as may appear to be due to said Bailey, in consequence of payments made by him on the property of insolvents, which it appears by certificate from the terks of the commissioners of the tax for the city of Baltimore, and Baltimore county, would have een allowed him for the years eighteen hundred and three and eighteen hundred and four, if the eturns had been made in time.

AND BE IT ENACTED, That it shall be the duty of the said Thomas Bailey, before he pro- An account to eeds to execute or distrain the property of any person or persons for taxes or public dues in virtue be delivered, if this act, to deliver to such person or persons chargeable with the same, at least thirty days prethis act, to deliver to such person or persons chargeable with the same, at least thirty days preous to the levying such execution or distress, an account, written in words at full length, of the axes demanded of him, her or them, with an affidavit annexed, if required, that he hath not reeved any part thereof, or any thing as security or satisfaction for the same, more than credit given, the best of his knowledge.

V. And he it enacted, That the said Thomas Bailey, before he derives any benefit from or lodged, &c. nder this act, shall lodge a copy of his collection books in the clerk's office of Baltimore county, to e open for the inspection of all persons interested in the same.
